

STÅRGÅTE: THE NEXT GENERATION



UNIFORM CODE OF CONDUCT

RATIFIED ON THE 5TH OF MAY, 2008

Ratification:

This document must be ratified by the MAJCOM CO, XO, and JAG as defined by the Constitution of Stargate: The Next Generation before it goes into effect.

Article I: Jurisdiction

These Articles of the Uniform Code of Conduct shall be applicable to all members of Stargate: The Next Generation who have willingly registered and thus subjected themselves to this document. The jurisdiction of this document shall not exceed SGTNG.

Article II: Higher Law

At any time when a higher law, defined as that of the State of California or that of the United States, or any international Law or Treaty recognized by the United Nations, conflicts with any article of this document, the higher law shall be applicable and shall overrule any article defined within this document.

Article III: Rights of the Accused

When a member is accused of violating this document, the accused member shall have the right to not give incriminating testimony against him or herself. The member is entitled to a fair and just court-martial tried by the JAG of SGTNG.

Article IV: Accessory After the Fact

Any member who, knowing that an offense punishable by this document has been committed, receives, comforts, or assists the offender in order to hinder or prevent his apprehension, trial, or punishment shall be punished as a Court-Martial may direct.

Article V: Attempts

Any member who attempts or shows reasonable effort to violate any of the articles of this document, regardless of success or failure, shall be punished as a Court-Martial may direct.

Article VI: Conspiracy

Any member who conspires with another member or non-member to violate any of the articles of this document, with reasonable intent to act upon the conspiracy, shall be punished as a Court-Martial may direct.

Article VII: Contempt towards Officers

Any member who willfully acts in a contemptuous manner towards Senior Officers, as defined as the MAJCOM Staff, Division Staff, and any such persons defined to be Senior Officers by the MAJCOM Staff, shall be punished as a Court-Martial may direct.

Article VIII: Disrespect towards Superiors

Any member who willfully shows disrespect towards a superior official shall be punished as a Court-Martial may direct.

Article IX: Failure to Obey Lawful Orders or Regulations

Any member who willfully refuses to obey or carry out a lawful order or regulation shall be punished as a Court-Martial may direct.

Article X: Dereliction of Duty

Any member who willfully is derelict in performing the member's duties shall be punished as a Court-Martial may direct.

Article XI: Cruelty and Maltreatment

Any member who willfully acts in a cruel manner or maltreats any members under his or her jurisdiction shall be punished as a Court-Martial may direct.

Article XII: Espionage

Any member who is found to be willfully acting as a spy or conducting espionage against SGTNG for another entity or organization shall be punished as a Court-Martial may direct.

Article XIII: Falsified Documentation

Any member who willfully and knowingly makes an official statement or order, with the knowledge that it is false and unauthorized, and with the intent to utilize it in an official fashion, shall be punished as a Court-Martial may direct.

Article XIV: Property of SGTNG

Any member, who willfully destroys, damages, vandalizes, disposes of without authorization, or otherwise renders unusable or damaged any property of SGTNG shall be punished as a Court-Martial may direct.

Article XV: Harassment

Any member who willfully acts in a harassing or otherwise disrespectful manner against another member, and when requested to fails to cease the harassing or otherwise disrespectful behavior, shall be punished as a Court-Martial may direct.

Article XVI: Breach of Peace

Any member who willfully disrupts the peaceful operation of SGTNG's internet assets or causes widespread breach of the peace shall be punished as a Court-Martial may direct.

Article XVII: Forgery

Any member who willfully and knowingly, with intent to commit fraudulent actions, falsely passes on any forged documents or signatures as official or authorized, shall be punished as a Court-Martial may direct.

Article XVIII: Threatening Actions

Any member who willfully and knowingly commits threatening actions shall be punished as a Court-Martial may direct.

Article XIX: Extortion

Any member who violates the 28th Article, with the intent to attain unlawfully anything of value, advantage, or immunity, shall be punished as a Court-Martial may direct with the knowledge that a violation of this article is more severe than the 28th Article.

Article XX: Conduct Unbecoming

Any member who commits any act that is discrediting or damaging to SGTNG, or commits any act that is unbecoming of a member of SGTNG, shall be punished as a Court-Martial may direct.

Article XXI: In-character regulations

In character on the simulation, all regulations of the Uniform Code of Military Justice (UCMJ) of the United States of America shall apply to all members, regardless of rank or out-of-character positions of leadership.

Article XXII: General Article

Though not specifically mentioned in this chapter, all disorders and neglects to the prejudice of good order and discipline in SGTNG, all conduct of a nature to bring discredit upon SGTNG, and crimes and offenses, of which members may be guilty of, shall be punished as a Court-Martial may direct.

Article XXIII: Amendments and Additions

Amendments or Additions to this document must be approved by the MAJCOM CO, MAJCOM XO, and JAG before implementation and effectiveness. Any such approved Amendments or Additions shall henceforth be considered an acting part of this document as if they were part of the original document.
